It is to inform you that the Hon'ble Punjab and Haryana High Court in the above mentioned Criminal Miscellaneous passed the orders to create passwords for doctors working in the private institutions for preparing Medico Legal Reports by using the MedLEaPR software developed by National Informatics Centre (NIC) Haryana. It has been informed number of times to the Indian Medical Association (Haryana Chapter), to all the Civil Surgeons and recently advertisements were given in English News papers on the above mentioned subject, however, there is poor response from the private institutions.



It is further, stated that the hospital authorities acting as HOD of particular hospital will sign the application form which contains detail of all the doctors who are preparing the MLR/PMR and send it personally or through registered post alongwith a bank draft Rs. 2000/- per doctor per institutions in favour "DGHS Reimbursement Fund "Payable at Panchkula along with the application. The application is to be send to the Deputy Director (PM) O/o Director General Health Services Haryana, Sector-6, Panchkula They will also pay a sum of Rs. 1000/- per doctor per institution per year as maintenance cost.

4. A copy of the instructions are again enclosed for your ready reference.

5. Kindly contact the President, Indian Medical Association (Haryana Chapter) of your District and explain him about the seriousness of the Hon'ble Court orders, failing which they will be responsible for themselves if any contempt proceedings are initiated by the Hon'ble Court.
